Chief shared the following:

School is back in and the area is being patrol. The speed zone is 25 mph is being enforced.

The police department is doing Abandon House checks as the homeless population is making camp in these properties.

1033 Military is an entity Chief Williams signed up for through the State of South Carolina – provide to law enforcement free of charge excess military equipment. Therefore, the Town of Swansea police department received First Aid Kits; New Sirens and Office Supplies. All of this was at zero dollars cost to the town.
