# TOWN OF SWANSEA COUNCIL GENERAL MEETING MARCH 21, 2022

#### **ATTENDANCE**

The Swansea Town Council meeting was called to order by Mayor Viola McDaniel at 6:00 P.M. at 320 West Third Street in Swansea SC. All media notifications went out and the postings were put at town hall, the police department and the town website.

The Mayor offered silent prayer prior to starting the meeting. Afterward, the pledge of allegiance was recited.

The Mayor asked for a consideration to approve the minutes. She stated, we will do this in two parts. The first minutes we are going to approve are the minutes of February 23<sup>rd</sup> and March 14<sup>th</sup>. Do we have a motion for the consideration for approval these two dates?
