A follow up on the study, they are in the process of good, faith negotiations with Attorney Dickey and his colleagues about long, term agreement. They took the liberty, with your knowledge of applying for some state funding to get into that deadline of March the third thru fourteenth, whenever it was early this month, with both Rural Infrastructure Authority and the State Revolving Fund.

They also talked with state leaders; in addition to pursuing some additional assistance through local state delegation to see if there's a chance of getting into this, the second round of appropriation.

### **BOOKKEEPERS REPORT**

Timothy Hillian shared with council his monthly report for February 2025. Revenue Expense Report - Statement of Cash and Debt. What was in the bank of cash this morning, and debt as of February for the two loans. USDA Loan and Truist Bank as well the interest paid on the loans.
