TOWN OF SWANSEA COUNCIL GENERAL MEETING JULY 22, 2024

The meeting was called to order at 6:00 PM by Mayor Pro Tem Linda Butler at the Swansea Municipal Court Room, 320 West Third Street, Swansea, SC 29160.

There were sufficient council members in attendance, therefore, a quorum was met.

All media notifications were sent out and the proper posting at town hall, police department and the town website.

Council was led in prayer by Christine Keefer followed by Councilman Jerome Williams with the pledge of allegiance.

Mayor Pro Tem Butler asked the visiting colleague of Attorney Dickey to introduced himself to council. Attorney Ronald Scott of Haynsworth Sinkler Boyd shared he was at the towns disposal to answer any questions or offer assistance in their meeting.

The towns minutes of June 5 and June 24th was presented for consideration for approval. A motion was made by Councilwoman Simmons and second by Councilman Williams.

Motion passed unanimously

MAYOR AND COUNCIL COMMENTS

Councilwoman Simmons shared she attended the SC MASC Annual Meeting in Greenville with councils Butler and Williams. Where she attended classes on different issues related to the towns and the residents of the towns giving ideas and bringing them up to date on a number of things they may not be aware of.

Legislation updates:

- Millennian generations X, Y and Z are the people we are going to be hiring in our town. Learn how to get them in. There thoughts are different with not as much a loyalty thing.
- Attitude with the new generation is different. If you can get them to stay and work a year, the towns are lucky.
- Improve our thought pattern to help this age group stay longer than a year.
- A Citizens Academy training residents who are interested in looking into working within government.

Councilman Williams shared what stood out most to him:

- Other municipalities basically deal with the same thing as Swansea. However, their cohesiveness was way better than what he has experience within Swansea.
- They disagree but respect others' opinions. If they as council can do a better job at that to include himself. Swansea and council would be a lot better off moving forward.

Pro Tem Butler had a different experience as the lights went out in her area at the hotel. She went back to bed. Nevertheless, she had a great time. She wants the town to continue to move forward.

The First Reading of Animal Control Amended Ordinance by title only Councilwoman Simmons put a motion on the floor to accept the Amendment On the Lexington County Animal Control Ordinance 24-03. Motion was second via Jerome Williams.

Motion passed unanimously

Tammy Caudill of Peba shared with councilmember that they and Mayors are considered full time employees for insurance purposes.

The Town must offer insurance benefits to the councilmembers/Mayor and must pay the employer share for the benefits they choose. The councilmembers/Mayor may refuse the coverage under the town.

- Any councilmember/Mayor who is on a spouse's PEBA insurance coverage must come off that coverage and elect coverage under the Town.
- If you are retired from the State and you return to work in an insurance eligible position with the State as a councilmember/Mayor, you must elect active insurance coverage or refuse all PEBA -sponsored coverage.
- This is a onetime chance to opt out of offering insurance benefits to the
- Councilmember/Mayor.

ADMINISTRATOR REPORT

Christine Keefer shared the towns monthly Administrator's report.

- In search of Police Chief search committee now has 4 applicants To consider for possible interviews.
- Budget and Finance.

Water and Sewer System evaluation Grants

Who does what, whether the town is properly staffed, need for more or less. If the town should be filling positions, they need but do not have them right now.
